4. Government Representative Updates:

- Jenny Portillo for Councilman Bob Blumenfield, District 3
- The Councilman stayed on Budget and Finance committee, as wells a Arts, Parks and River, Energy and Environment, Trade, Commerce and Technology, and the on the Ad Hoc committee on Comprehensive Job Creation Plan.
- Councilman is working on a motion to stop "for sale" vehicles on Sherman way. The Councilman is seeking public support of the motion. The Transportation Commission meets 2nd and 4th Wednesdays. We will put on our agenda for next month for action.

There have been some efforts to determine if the cars are really being sold by individuals or by an organization since many used to have the same telephone number. Some numbers have changed now but there still seem to be many with same or similar numbers.

- (Reyes-Dunn) Asked if the cars parked at the old "U Haul" lot might be part of the operation that is selling cars..
- Councilman is studying possibility of adding fencing at Winnetka Park to isolate adjacent homes from homeless living in park.
- (Lewis) People are being allowed to sleep in their cars currently. Not illegal right now. Some people who have jobs are living in cars by choice. City is looking into solutions.
 - Homeless are sleeping in cars and motor homes and occupying neighborhoods.
 - (H. Poer) reported incident with neighbor whose home was broken into 3 times by people to "live" in her house.
- ❖ DOT representatives can't come to evening meetings because of overtime issues and most Board Members cannot attend during the day.
- Ankur Patel, new School and Community Coordinator, assistant to Scott Schmerleson, LAUSD. Wants to coordinate with WNC to obtain a list of all of the schools and educational institutions in Winnetka, public and private. (Owen) will try to help recruit people to help.
- **5.** Presentation or Guest Speaker, and Q&A. No guest speaker for this meeting.

(S. Bardo): Says he has been trying to get on our email list for a year and hasn't had success. He found that his email had been incorrectly input with Constant Contact. He also commented that other stakeholders had experienced difficulties receiving email notifications.

WNC Beautification Liaison to C. Blumenfield's Office, in coordination with the WNC PWT

• Report on the Summary of the WNC Zine Funds.

At the end of our fiscal year 2012-2013, outgoing Councilman Dennis Zine gifted our WNC (Winnetka Neighborhood Council) with \$50,000, to only be used within the City of LA's Bureau of Street Services (BOSS). The WNC PWT Committee (Public Works & Transportation Committee) was charged with properly dispensing the funds by having work done within Winnetka. The \$50,000 was spent in two main areas:

- A) Small asphalt repairs to sidewalks and streets, for a total of \$28,400.00 of the Zine funding.
- B) Tree trimming, for a total of \$21,000.00 of the Zine funding. This leaves a balance of \$600 unused of the Zine funding. it is as close to the total funding cap as was possible. The remaining \$600 reverted back to the City as of June 30, 2015.
- Within our Winnetka borders, the sidewalks and streets along Winnetka Ave., Mason Ave, Saticoy St. and Vanowen St. had about 2,072 total repairs covering approximately 7,437 square feet. All this work was performed by pothole crews from the Street Maintenance Division, BOSS, mainly coordinated by Bill Candlish.
- O Within our Winnetka borders, the trees along Winnetka Ave. were trimmed beautifully by the Urban Forestry Division, BOSS, coordinated by Timothy Tyson.
- WNC thanks: C. Bob Blumenfield and Jenny Portillo for extending the Zine fund deadlines [more than once!]; all of the crews that worked in Winnetka from the Bureau of Street Services' Street Maintenance Div. headed by Bill Candlish and Ron Lorenzen, and crews from the Urban Forestry Division headed by Timothy Tyson; and our own members of the Public Works & Transportation Committee, namely David Uebersax and Bettie Ross-Blumer, and Eric Lewis, for all they have done to use the \$50,000 Zine funds to benefit Winnetka.
- Plantings on the Sherman Way medians: We are looking to complete the plantings along the Sherman Way left-hand-turn medians using drought-tolerant plants, instead of the white iceberg roses. We are owed money from the nursery for the iceberg roses. May need to find other plantings.
- The "Welcome to Winnetka" sign on Sherman way (two signs, one at Corbin, one at DeSoto): As noted by John Poer, these two signs are in need of clean-up, and for visibility, they need brush removed from in front of them, and they may need to be elevated by a foot or more.
- Discussion of the fact that the water has been shut off on the medians, "until further notice."

PROCESS FOR RECONSIDERATION

The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place immediately following the original action or at the next regular meeting. The Board, on either of these two days, shall: (1) Make a Motion for Reconsideration and, if approved, (2) hear the matter and Take an Action.

If the motion to reconsider an action is to be scheduled at the meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) A Motion for Reconsideration on the described matter and (2) a {Proposed} Action should the motion to reconsider be approved. A Board member who has previously voted on the prevailing side of the original action taken can only make a motion for reconsideration

If a motion for reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Brown Act.

PROCESS FOR FILING A GRIEVANCE

Any grievance by a Stakeholder must be submitted in writing to the Secretary of the Board of Directors. The Secretary shall then within no more than 30 days refer the matter to an ad-hoc grievance panel comprised of 3 Stakeholders who are randomly selected by the Council

Secretary from a list of Stakeholders who have previously expressed an interest in serving from time to time on such a grievance panel. The Secretary will coordinate a time and a place, not to exceed 10 days, for the panel to meet with the person(s) submitting a grievance and to discuss ways in which the dispute may be resolved.

Thereafter, a panel member shall promptly prepare a written report to be forwarded by the Secretary to the Board to be heard at the next board meeting outlining the panel's collective recommendations for resolving the grievance. The Board of Directors may receive a copy of the panel's report and recommendations prior to any meeting by the Board, but the matter shall not be discussed among the Board members until the matter is heard at the next regular meeting of the Board pursuant to the Ralph M. Brown Act.

This formal grievance process is not intended to apply to Stakeholders who simply disagree with a position or action taken by the Board at one of its meetings. Those grievances can be aired at the Board meetings. This grievance process is intended to address matters involving procedural disputes, e.g., the Board's failure to comply with the Board's Rules or Bylaws, or its failure to comply with the City's Charter, the Plan, local ordinances, state law, and/or federal law.

In the event that a grievance cannot be resolved through this grievance process, the complainant has the right to appeal the matter to the Department of Neighborhood Empowerment for consideration or dispute resolution.
