If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

6) **GOVERNMENT REPRESENTATIVES**:

A Updates/reports from officials/representatives of the offices of Mayor Garcetti, City Council District 3 Councilmember Bob Blumenfield, State Senator Henry Stern, State Assembly Jesse Gabriel, US Congressmember Brad Sherman, LA County Supervisor Sheila Keuhl, LAUSD Board Member Scott Schmerelson, LAPD and/or CPAB, LAFD, Dept. of Neighborhood Empowerment (DONE), Board of Neighborhood Commissioners (BONC), Neighborhood Council Budget Advocates (NCBA), other local, state, or federal agencies.

Safi with Councilmember Blumenfield: Concerts in the park are live as of next week until mid August. Valley Culture Center's website. Ribbon cutting of the Winnetka Park improvements was completed.

June 20th is Juneteenth, which is a City holiday.

Erick: Chase St between De Soto and Mason, there have been speed bumps installed. He thought the neighborhood needed to agree before installation? What is the process?

Juan: All of the way to Corbin there has been installation.

Safi: Covid has changed the process. There are reports from DOT and petitions from the block. School zones can request from the Principal of the school. He is unsure if the neighborhood is asked for input prior to the installation. The process has a petition phase and the DOT engineering phase. Since April 2020, they have put a holds in place.

David: Found a post on June 1st social media for the Councilman, regarding a request for speed bumps to stop speed racing.

Safi: Removing the speed humps is the same process of petitions and then review.

Juan: Thank you for the ribbon cutting. Is there any help the park can get to add trees to the walkway or Chase St or the Park general?

Safi: Rec and Parks Dept. City Plants is a city contractor. He will find out more.

Samantha: Has recently gotten involved with Tree People, which is a non profit that's goal is to plant more trees. They work together with Cities. She will reach out to Tree People to see if they have resources for the Winnetka Park. They also focus on more than just the planting, but also the initial management of caring for the tree. New trees need additional water and maintenance.

David: The Tree People are a great resource and have a strong history.

Judith: Pennfield alley homeless have returned. She is having difficulty going through the alley, and has had very negative experiences with a new encampment in the alley.

Safi: The cleanup is scheduled on June 16th. Cleanups are making a dent. Outreach has been extended to them.

Juan: Would like to support expanding the area of 1000 ft of schools to prevent encampments as requested by LAUSD superintendent to the City Council. Let's do something now, rather than letting it get worse.

Safi: Has not heard of the 41.18 expansion request from LAUSD. Will look into this further.

David: Can you discuss the RVs and cleanup on Mason between Van Owen and Victory.

Safi: There has been a series of cleanups on Mason. They have been approached by outreach multiple times. Some of them are intending to leave soon. However, soon was not defined. Elkwood has been approached many times. He comes and goes. His location is on the cleanup list as well.

David: We got some information about the pit, to have a 5 story building installed at the corner of Mason and Sherman Way. Do you know more?

Safi: Does not have knowledge of the planning committee or where they are in the process.

Myrna with Supervisor Keuhl's office: Stormwater project in Canoga Park. More details are coming. Covid cases are rising again, so they are advising people to be safe.

David: June LA River Cleanup on June 25th. Can we get access to the River as a Neighborhood Council to assist and fill in the gaps with cleanup?

Myrna: She will connect with Blake and get back with more information.

Mikkie Loi: Officer Zamora is on vacation. Concerns can be emailed to DevonshireSLO@LAPD.online

Devonshire Division has created a class starting July 11 to learn more on how to protect ourselves. Waiting list is still open.

Vanessa Serrano from DONE: Mario was double booked.

David: Did AJ's code of conduct come through? And, we need to do some updates to our roster information

Vanessa: Will look into it. Also, roster updates have been a bit backlogged.

David: Will meetings be staying online?

Vanessa: They are evaluating all of the required equipment and options for hybrid meetings. The Board of Neighborhood Commissioner meeting was scheduled for June 20, but now that it is a holiday they will need to reschedule. Until there are instructions for how to do a hybrid model, they are planning to continue using the remote meetings.

Monthly email updates include all of the training and workshops that are ongoing.

Erick: We are on with Mario on Wednesday at 1pm?

David: 1-2:30 on Thursday.

Glenn Bailey with Budget Advocates: Bi-annual elections are happening at the end of the month. June 25 / 26 will assign their own date and time for the elections. Budget advocates are the only eligible candidates for the position. NC treasurer or President are able to vote in their stead. Budget Day is June 18th, with registration sent out by email or from the Budget Advocates website.

David: Budget Advocate is open to our NC members if they express interest. Can we still contribute to the Budget Advocates?

Glenn: We are working through a public process to try and ensure that this is possible.

RECONSIDERATION AND GRIEVANCE PROCESS

The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place immediately following the original action or at the next regular meeting. The Board, on either of these two days, shall: (1) Make a Motion for Reconsideration and, if approved, (2) hear the matter and Take an Action.

If the motion to reconsider an action is to be scheduled at the meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) A Motion for Reconsideration on the described matter and (2) a {Proposed} Action should the motion to reconsider be approved. A Board member who has previously voted on the prevailing side of the original action taken can only make a motion for reconsideration.

If a motion for reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Brown Act.

PROCESS FOR FILING A GRIEVANCE

Any grievance by a Stakeholder must be submitted in writing to the Secretary of the Board of Directors. The Secretary shall then within no more than 30 days refer the matter to an ad-hoc grievance panel comprised of 3 Stakeholders who are randomly selected by the Council Secretary from a list of Stakeholders who have previously expressed an interest in serving from time to time on such a grievance panel. The Secretary will coordinate a time and a place, not to exceed 10 days, for the panel to meet with the person(s) submitting a grievance and to discuss ways in which the dispute may be resolved.

Thereafter, a panel member shall promptly prepare a written report to be forwarded by the Secretary to the Board to be heard at the next board meeting outlining the panel's collective recommendations for resolving the grievance. The Board of Directors may receive a copy of the panel's report and recommendations prior to any meeting by the Board, but the matter shall not be discussed among the Board members until the matter is heard at the next regular meeting of the Board pursuant to the Ralph M. Brown Act.

This formal grievance process is not intended to apply to Stakeholders who simply disagree with a position or action taken by the Board at one of its meetings. Those grievances can be aired at the Board meetings. This grievance process is intended to address matters involving procedural disputes, e.g., the Board's failure to comply with the Board's Rules or Bylaws, or its failure to comply with the City's Charter, the Plan, local ordinances, state law, and/or federal law.

In the event that a grievance cannot be resolved through this grievance process, the complainant has the right to appeal the matter to the Department of Neighborhood Empowerment for consideration or dispute resolution.
