The 160 acres on which the Sepulveda VA stands were donated to the U.S. Government March 19, 1952 specifically for a full service Veterans hospital-medical center. Therefore, the coalition is opposed to any private sector development (public, profit or non-profit) at the Sepulveda VA and demands cancellation/rescission of the 75-year Enhanced Use Leases between the VA and the consortium of developers New Directions (ND) and A Community of Friends (ACOF); cancellation of the ACOF/New Directions apartment project and urges that buildings 4 and 5 be refurbished and staffed as medical buildings, the hospital rebuilt and the Sepulveda VA restored as a full service hospital-medical center, starting with buildings 4 and 5.

It is important to note that every neighborhood council in the San Fernando Valley that has adopted a position on the proposed Sepulveda VA project has voted to oppose the ND/ACOF project and all private sector development on VA property. We hope all those who have not yet adopted a position, will soon join us in our opposition and vote to save our Veterans Land, Assets and medical centers not only here but throughout the U.S. Our aging Veteran population and all those who will be returning from Iraq, Afghanistan and elsewhere need and are entitled to hospitals and full service medical centers in their immediate areas. The VA's wholesale giveaway of Veterans land and assets to private sector developers is criminal and it must be stopped. With your help we will stop it starting right here at the Sepulveda VA in the San Fernando Valley
